MEMORANDUM FOR: Acting Deputy Director for Support

SUBJECT: Proposed Withdrawal of Mr. [REDACTED] from the 1967-1968 Session of the Air War College 25X1A9a

1. This memorandum contains a recommendation for your approval. Such recommendation is contained in paragraph 2.

2. Based on our nomination, Mr. [REDACTED] was selected by the Training Selection Board, and subsequently by the Agency, to attend the 1967-1968 session of the Air War College. It was recognized by the Office of Logistics, at the time Mr. [REDACTED]'s name was submitted, that his selection and the subsequent loss of his services for a period of 10 months would be a hardship on the Real Estate and Construction Division. 25X1A9a

3. In February 1967 we were requested to submit a candidate for the Nidexear Educational Program in Systematic Analysis for the academic year 1967-1968. Again, to submit the best possible candidate for this program, we selected one of our outstanding professional employees, Mr. [REDACTED] an Engineer in the Real Estate and Construction Division. It now appears that Mr. [REDACTED] will be attending this program for the period September 1967 through June 1968, which is approximately the same period of time as the Air War College to which Mr. [REDACTED] is nominated. 25X1A9a

The need to replace Mr. [REDACTED] with an Engineer, coupled with our having supplied three Engineers to DCSST during the past 6 months for new requirements, and an unusually heavy schedule of construction and alteration programs in Headquarters and the field has caused us to re-examine our capability of sending Mr. [REDACTED] to the Air War College at this time. 25X1A9a

Due consideration has been given to all facets of this problem with the conclusion drawn that it would be in the best interest of the Agency, at this time, to withdraw Mr. [REDACTED] from the 1967-1968 session of the Air War College.
