- 1. CAMERA B 11 WAS USED IN MISSION 3719 FLOWN ON 12 SEPTEMBER 1963; PROCESSING WAS ACCOMPLISHED BY BARKSDALE.
  - 2. ORIGINAL NEGATIVE:
    - A. THE EXPOSURE WAS ADEQUATE AND THE RESOLUTION IS GOOD.
- B. 9R SIDE: FOREIGN MATTER (INSECTS) ARE PRESENT ON FRAMES 191, 192 AND 193. SEVERE POST PROCESSING LONGTITUDINAL SCRATCHES RUN THROUGH THE CENTER OF FRAMES 227 AND 228.
- C. 9L SIDE: THERE IS A CHEMICAL STAIN ON FRAME 053, AND A MANUFACUTURING SPLICE ON FRAME 897. THE TWO FRAMES FOLLOWING THE HEAT SPLICE (898 AND 899) CONTAIN PINHOLES AND ARE CREASED.

- D. BOTH SIDES: THERE ARE PROCESSING STREAKS THROUGHOUT.

  THE SHUTTER FAILED TO OPEN ON FRAME 1501. THE TOTAL NUMBER OF

  TITLED FRAMES IS 1521; HOWEVER, THE DATA SHEET INDICATES THAT THERE

  SHOULD BE A TOTAL OF 2,444 FRAMES.
- E. BECAUSE OF THE DISCREPANCY IN THE TOTAL NUMBER OF FRAMES, IT IS POSSIBLE THAT A CAMERA MALFUNCTION OCCURRED. OTHER THAN CONTINUOUS PROCESSING STREAKS, THERE WERE NO SERIOUS PROCESSING PROBLEMS NOTED.

- A. PI SUITABILITY WAS GOOD WHERE WEATHER PERMITTED. THE PRINTS OF PART 6, FRAMES 1500 TO 1521, WERE NOT RECEIVED.
