1. CAMERA B-11 WAS USED IN MISSION 3705 FLOWN ON 29 AUG 63;  
PROCESSING WAS ACCOMPLISHED BY BARKSDALE.

2. ORIGINAL NEGATIVE:

A. THE EXPOSURE WAS ADEQUATE AND THE RESOLUTION IS GOOD.

B. 9R SIDE: A LONGITUDINAL EMULSION SCRATCH 4.35" FROM THE  
INBOARD EDGE OCCURS INTERMITTENTLY THROUGHOUT THE ENTIRE MISSION  
AS EXEMPLIFIED BY FRAMES 2232 TO 2248, AND 1599 TO 1622. THE POSITION  
INDICATOR LIGHTS ARE GHOSTED THROUGHOUT; AND MANUFACTURING SPLICES,  
WITH ASSOCIATED STATIC, PINHOLES, ETC., ARE LOCATED ON FRAMES  
1679 AND 793.

C. 9L SIDE: FRAME 593 CONTAINS A 10" LONG AND 0.3" WIDE

CHEMICAL STAIN. THERE IS A MANUFACTURING SPLICE ON FRAME 2165 WITH ASSOCIATED CREASES ON THE FOLLOWING TWO FRAMES.

D. BOTH SIDES: CONTINUOUS BUT MINOR PROCESSING STREAKS OCCUR THROUGHOUT AND THE METERING IS SLIGHTLY ERRATIC. THERE ARE 2449 TITLED FRAMES ON EACH SIDE.

E. NO MAJOR CAMERA MALFUNCTIONS OR PROCESSING PROBLEMS OCCURRED IN THE MISSION.

3. POSITIVE:

A. PI SUITABILITY IS GOOD AND THE PRINTING AND PROCESSING OF THE DUPLICATE POSITIVE WAS GOOD.

B. CLOUDS OBSCURED ABOUT 25 PERCENT OF THE TAKE.
