FOREIGN MATTER, AND ON FRAMES 517 AND 1222 ARE FOUND BLISTERS.

C. 9L SIDE: CAMERA PRESSURE ROLLER STATIC ON THE INBOARD EDGE AND EDGE STATIC ON THE OUTBOARD EDGE DEGRADES FRAMES 1 THROUGH 300. AN EYELASH-SHAPED MINUS DENSITY AND A MINUS DENSITY SPOT ARE FOUND 3.2" FROM THE OUTBOARD EDGE OF FRAMES 60 THROUGH 433. THE METERING BECAME SLIGHTLY ERRATIC FROM FRAMES 1800 TO 2229, THE END OF THE MISSION.

D. BOTH SIDES: THERE ARE MINOR PROCESSING STREAKS THROUGHOUT THE ENTIRE MISSION ON BOTH SIDES. THERE WAS A TOTAL NUMBER OF 2229 FRAMES ON EACH SIDE.

3. POSITIVE:

A. THERE WERE NO PROCESSING ANOMALIES OR CAMERA MALFUNCTIONS FOUND ON THIS MISSION EXCEPT FOR THOSE LISTED ABOVE.

B. PI SUITABILITY IS GOOD.

C. CLOUDS MASKED ABOUT 40 PERCENT OF THIS MISSION.

D. THE CAMERA NUMBER IS ILLEGIBLE AND THE CAMERA DATA SHEETS WERE NOT RECEIVED.
