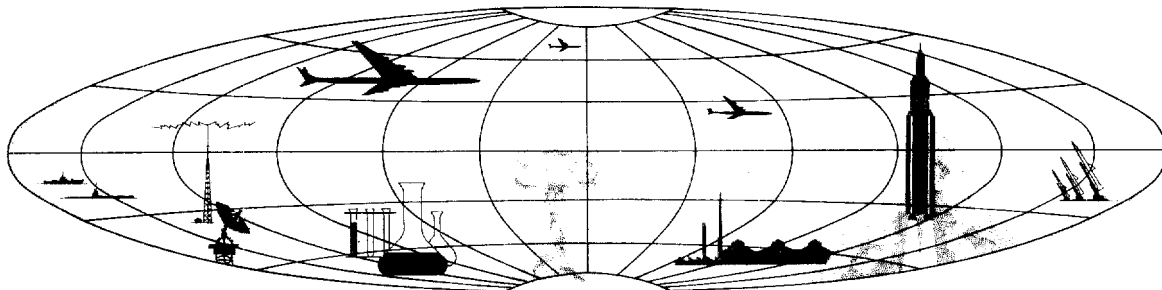

KAPOLNASNYEK PETROLEUM STORAGE AND PUMPING STATION, HUNGARY

This report is a partial answer to DIA requirement DIAXX 63-84, to verify the location of selected military installations in Hungary and to perform a photo analysis to determine function, number and dimensions of buildings, to estimate troop capacity, to identify and describe related training areas and facilities and to confirm or negate ammunition and POL storage.

25X1D Good quality photography of [REDACTED] was used in the analysis of this installation.
25X1D KEYHOLE photography of [REDACTED] permitted identification of the installation, but poor image quality and small scale precluded analysis.

The installation described below is shown in Figure 1.

This secured installation 1.5 miles east-northeast of Kapolnasnyek covers approximately 4 acres and contains:

2 cylindrical storage tanks approximately 35 feet in diameter and approximately 20 feet in height, both protected by firewalls. An adjacent walled area is empty but circular ground scars indicate prior presence of a third tank.

1 small possible cylindrical tank approximately 15 feet in diameter and approximately 15 feet in height.

3 miscellaneous support buildings approximately 65 by 25, 30 by 30, and 35 by 15 feet.

No evidence of pipeline is observed in the immediate vicinity of the installation.
