SCHEDULE

PART I - CONTRACT WORK

The Contractor shall perform all work and services necessary to provide the following in accordance with its proposal dated 19 June 1964. Said proposal is incorporated into this contract by reference:

Item 1 - Furnish one (1) Norizon Camera System essentially in accordance with Contractor's Proposal N64-11, dated 5 March 1964. Differences in packaging may arise as a result of installation and space provisions.

Item 2 - Furnish one (1) Statoscope in accordance with Contractor's Proposal R64-10, dated 13 February 1964.

Item 3 - Installation Engineering requiring drawings to indicate the installation layout of Items 1 and 2, together with required modifications. in packaging to fit the installation, and supervisions of actual

PART IV - PAYMENTS

In accordance with the provisions of Clause 4 of the General Provisions of this contract entitled "ALLOWABLE COSTS, FIXED-FIE AND PAYMENTS," the Government shall pay the Contractor as full compensation

The fixed-fee shall be paid in monthly installments based on total allowable cost incurred by the Contractor and approved by the Contracting Officer computed at the same ratio that the fixed-fee stated herein is to the total estimated cost stated herein; subject however to the withholding provisions of Paragraph (c) of Coneral Provisions 4, ALLOWARIE COST, FIMED-FEE and PARHERY. The fixed-fee payable hereunder shall not exceed the amount therefor stipulated in the contract as it may be amended from time to time.

PART VI - HAIVER OF REQUIREMENTS OF GENERAL PROVISIONS
