SUBJECT : Search for Nuclear Weapons Storage Facility at SEVASTOPOL Naval Missile Storage Site, USSR

1. A search for a nuclear weapon storage facility at the Sevastopol naval missile storage site located six nautical miles (n.m.) east of Sevastopol (44 36 N 33 40 E) or within a 50 n.m. radius of the site was conducted on recent [Redacted] photography of the Crimean Peninsula.

2. No confirmed nuclear weapon storage facilities were found within a 50 n.m. radius of the Sevastopol naval missile storage site.

3. A double secured area, Area B, located within the Sevastopol naval missile storage site (see NPIC/R-98/63), is a probable explosives storage area having four large buildings which apparently have been built between the excavations seen on 1960 [Redacted] photography [Redacted]. The longest of these buildings appears to be a possible drive-through facility with the excavations on either end of the building acting as approach ramps from the main road. The remaining excavations present in 1960 cannot be identified clearly on recent photography, and their relationship, if any, to the three other large buildings cannot be determined. A small drive-through facility has been built on a branch road just east of the main north-south road passing through Area B. Several other small buildings are scattered throughout the area. 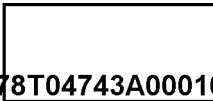

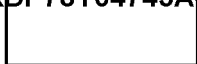
