- 1. We need to have strategy reports prepared on the PRC KIQs for FY 1976. These seven KIQs on China (35-42) are contained on pages 7 and 8 of referenced report. I propose we have three meetings to handle the strategy reports.
 - a. The first meeting would be on Wednesday, 12 November, at 1000 hours in 5G-00 at CIA Langley to cover KIQs 35 and 36.
 - b. The second meeting would be on Friday, 21 November, at 1000 in 5G-00, to handle KIQ 37.
 - c. The third meeting would be on 4 December, at 1000 in 5G-00, to handle KIQs 38, 39, 40, 41.
 - d. KIQ 42 will be handled by the NIO for Strategic Programs.
 - 2. The strategy sessions are supposed to do two things. First, establish specific collection targets and second, assign the various components collection and analytical tasks.
 - 3. I am attaching a sample of a strategy report in case you haven't personally been exposed to this phenomenon before. I hope Attendees will come prepared to help designate specific targets and also with contributions in the collection and analytical fields where applicable.
