[redacted] has the medallion in his personal possession and uses it as an artifact in his own home. Mr. [redacted] explains that he does this after having received permission to do so from the Office of Personnel. According to Mr. [redacted] the matter of the gift's proper disposition was raised innumerable times with the Office of Personnel. The issue was finally resolved in Mr. [redacted] favor, i.e., that he could keep it and take it home based on everyone's agreement that the item was clearly worth less than \$50.00 and that it was highly personalized in that it has [redacted] name inscribed on it.

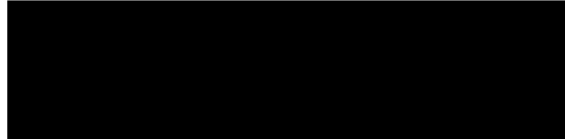
