As I mentioned today at this Morning's Meeting, Dr. [redacted] advised me on 10 November of a recent conversation with Mr. [redacted] of the DD/O. Mr. [redacted] stated that he was interested in learning what the Agency did currently in terms of counselling for people who were about to retire. He had been charged for the DD/O to look into this because Mr. [redacted] a DD/O retiree, had made a proposal for contractual relationship between the DD/O and Mr. [redacted]. This proposal would serve to have Mr. [redacted] provide DD/O operations officers, who are about to retire, with counselling service. Mr. [redacted] indicated to Dr. [redacted] that after his discussion with [redacted] he would probably recommend against Mr. [redacted] proposal being accepted by the DD/O since the Agency already had adequate facilities.
