I was concerned about your comments that the leaks [redacted] may have come from PFIAB. I checked with the PFIAB Secretariat and was advised that PFIAB had not been briefed on [redacted]. That doesn't mean, of course, that individual members have not received a [redacted] briefing. In a discussion on the NIEs, there was some brief mention of [redacted] before the PFIAB. I doubt we will ever find where these vicious leaks came from, but I did want to at least run down the possibility that a full-scale PFIAB briefing might have resulted in the leaks.
