BEACH, FLORIDA FOR DINNER AND DISCUSSION. IF THIS
DATE IS INCONVENIENT, IT WOULD ALSO BE POSSIBLE FOR ME TO MEET
WITH YOU ON THURS., SAT., OR SUNDAY EVENINGS, 17, 19 OR 20 AUG.

4. AT THE TIME I MEET WITH YOU IN PALM BEACH, I SHOULD HAVE
AVAILABLE COPIES OF THE US DRAFT PROPOSALS FOR STUDY
BY THE SOVIET GROUP. WOULD YOU BE ABLE TO HAVE AVAILABLE AT THAT
TIME FOR OUR STUDY DRAFT PROPOSALS FROM THE SOVIET GROUP?

5. I WILL BE GLAD TO HELP ARRANGE VISITS TO US RESEARCH
LABORATORIES FOR THE SOVIET GROUP DURING THE PERIOD FROM
SATURDAY, 26 AUG. THROUGH WEDNESDAY, 30 AUG.

6. I BELIEVE IT ALSO WILL BE NECESSARY FOR SMALL US GROUP
TO VISIT USSR IN SEPTEMBER TO AGREE ON THE FINAL PROPOSALS
TO BE PRESENTED TO THE JOINT COMMISSION IN OCTOBER. END QUOTE.
