Mr. Wisner as to whether he desired a working-level assistant to attend in order to sit in on meetings of the Security Subcommittee; this would not be appropriate for the CIA Senior Representative. I also explained to Adm. Stout the reasons why CIA insisted on taking no formal intelligence positions at such meetings, which were intended to stimulate collection rather than to advise the collectors. Adm. Stout confirmed my suspicion that these meetings, which had been conceived of as a means of securing additional intelligence from the
