Wednesday, 13 August 1952

1. Informed Mr. Wisner of Mr. Hedden's suggestion as to the security risk in the use of pseudonyms and requested that he have this matter gone into again, and Mr. Wisner undertook to do so.

2. With the approval of DCI, passed to Adm. Dennison and Mr. Adams of the Senate Small Business Committee a Russian Near East propaganda broadcast relating to oil monopolies in the Middle East.

Chatted with [REDACTED], the new Cable Secretary, and Mr. [REDACTED] to insure that copies of all cables containing substantive intelligence which would normally go either to DCI or DD/P simultaneously come to this office. Following this conversation, an appropriate notification was issued by the Cable Secretary and questions were raised by [REDACTED] of the Operational Offices. When I explained to them that these cables were intended for my information and not for further dissemination, all were satisfied as to this new arrangement and I confirmed this with Mr. Wisner. 25X1A9a

4. [REDACTED] of the Operational Offices consulted me as to the need for an Intelligence Officer, Grade GS-14. I later chatted with [REDACTED] to ascertain whether his man would be available and he had one suggestion which I thought he might discuss with [REDACTED] I shall also raise this at the IADs' meeting. 25X1A9a

5. Chatted with Col. Edwards and with [REDACTED] respecting a Russian defector being brought in under Section 8 and, upon being informed of DCI's decision that no comment should be made, I insisted that [REDACTED] follow these orders. 25X1A9a

6. Discussed with Drs. Chadwell, [REDACTED] and Andrews, and Jim Reber, the O/SI indexing project and, after further discussion, requested Dr. Andrews to withdraw his limited concurrence and attend the PRC meeting where this project was considered, in order to express his views on its limitations.

[REDACTED] and [REDACTED] O/SI relations (through FI) with [REDACTED] I indicated my view that they should assume that [REDACTED] would become more independent and also would have much closer relations [REDACTED] Accordingly, they would have to tread softly in passing information to that organization. 25X1X7 Frankly, I felt that we should trade things other than intelligence information to obtain intelligence from [REDACTED]

10. Mr. Sheldon reported to me on the work of the USCIB ad hoc committee and I approved the action being taken.
