1. Attached are lists of targets for use by NPIC and Operations in overhead reconnaissance programs. This file was updated on the basis of readouts [REDACTED]

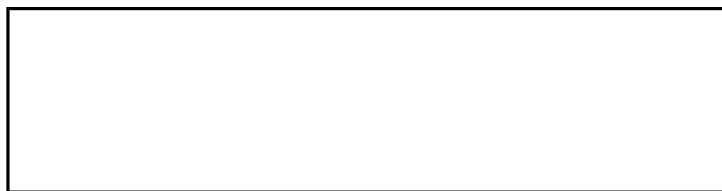
