4. There were no changes to the South China/North Vietnam Priority List. [ ] voiced the opinion that, in view of the present bombing halt in NVN, a revised priority paper for South China/North Vietnam might be in order. [ ] concluded the discussion by stating he feels that new USIB collection guidance for NVN under the cease fire agreement is required. The DIA member reported acceptable data base coverage of NVN targets as follows:

1106 ORBIT SELECT CRITERIA

5. [ ] informed the Committee that the orbit for 1106 had to be selected earlier than normal because of the secondary payload being carried. The following orbit select criteria was provided the NRO:

In order of priority:

- 1) Access to whole of USSR, Communist China, East European Communist countries, North Vietnam, North Korea and Middle East (Egypt, less area west of 30° East and south of 25° North, Israel, Jordan, Syria, Iraq (west of 45° East).
- 2) Multiple access to: "Holiday" \* areas in the USSR, Communist China, East European Communist countries, North Vietnam and (if any) North Korea.

\* Adjusted or weighed to account for climatology.
