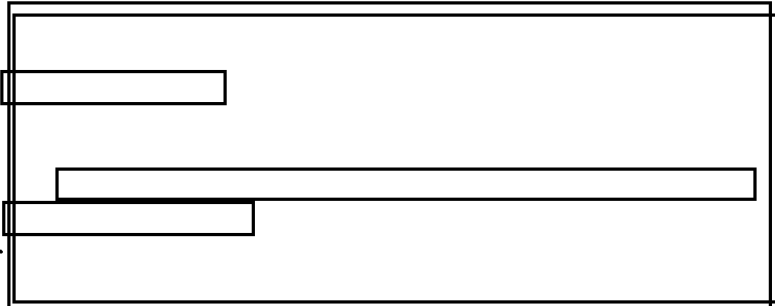
OAG CONTACTS:

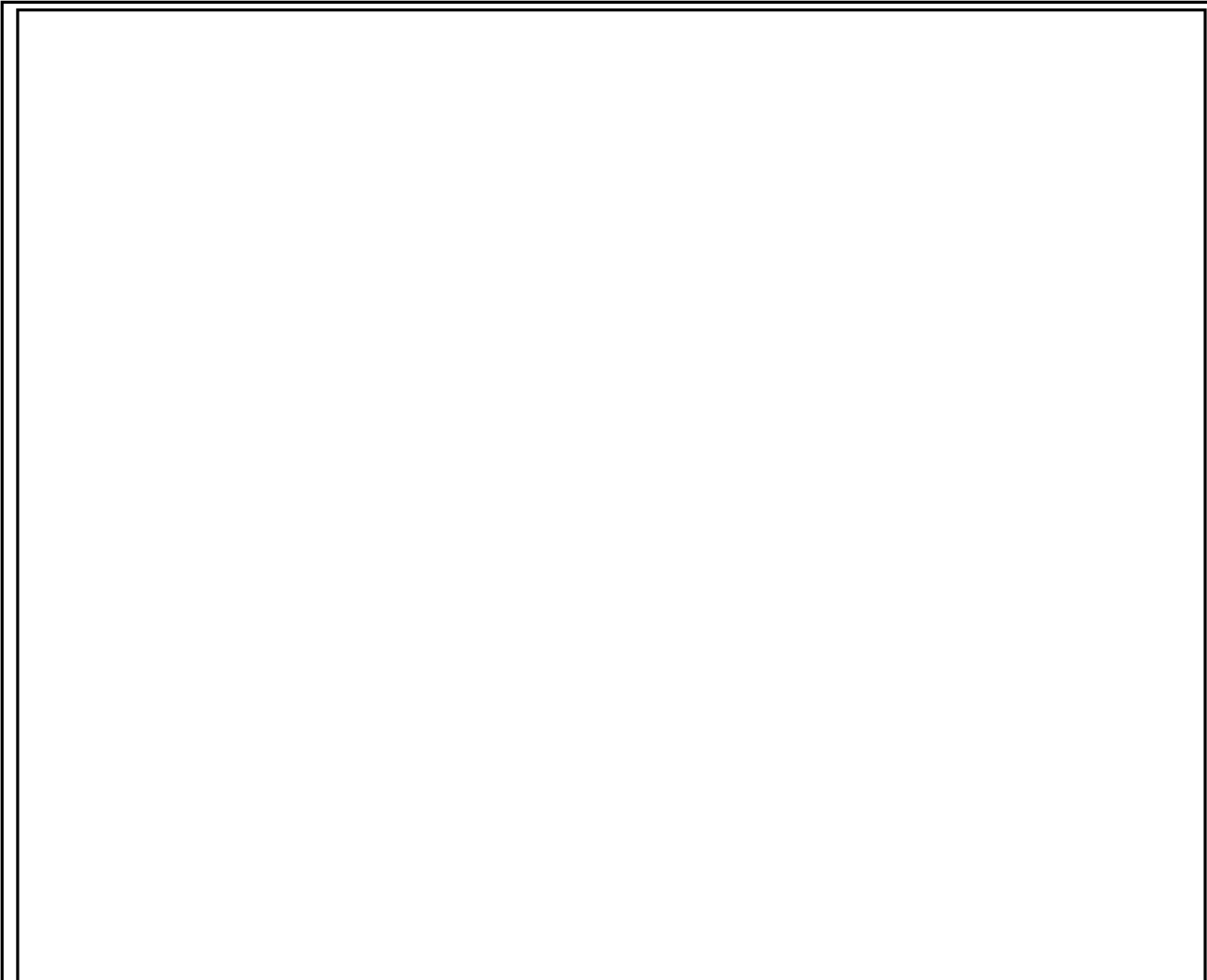
