Dear Mr. Attorney General:


I am advised by Mr. George L. Cary, Legislative Counsel, Central Intelligence Agency, that he has provided you a copy of his "secret/sensitive" letter to me of 14 May 1976. This letter relates to a preliminary investigation initiated by the Federal Bureau of Investigation into a matter in which the Agency has an interest and into which this Committee may also have an interest.

This Committee's interest would arise in the event that investigation revealed any information which might be directly or indirectly relevant to the Committee's responsibilities under H.
