MEMORANDUM FOR: Director of Central Intelligence

SUBJECT : Agency Pamphlet

This might well be a good time to start a project I mentioned to you: a new and more "with it" Agency pamphlet. Our goal would be to have a document that could be used both for informational and recruiting purposes.

Our tentative thoughts on the pamphlet are as follows:

- a. A standard size document  $(8-1/2 \times 11)$  of some six to eight pages.
- b. At least two photos of, for example, the library and the Headquarters building.
- c. Contents that include: a brief history of intelligence and of the CIA; a description of the spread of talents and academic backgrounds of Agency employees; a simple organizational chart with brief descriptions of the components (Directorate level only); a short study of two or three "typical" employees (probably analysts); and a closing emphasizing the importance to America of maintaining a professional and capable intelligence service.

If you approve such a pamphlet, we would hope to have a draft in your hands within about a month.
