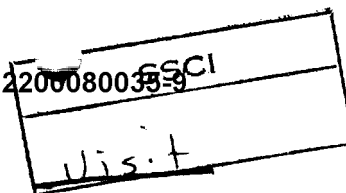

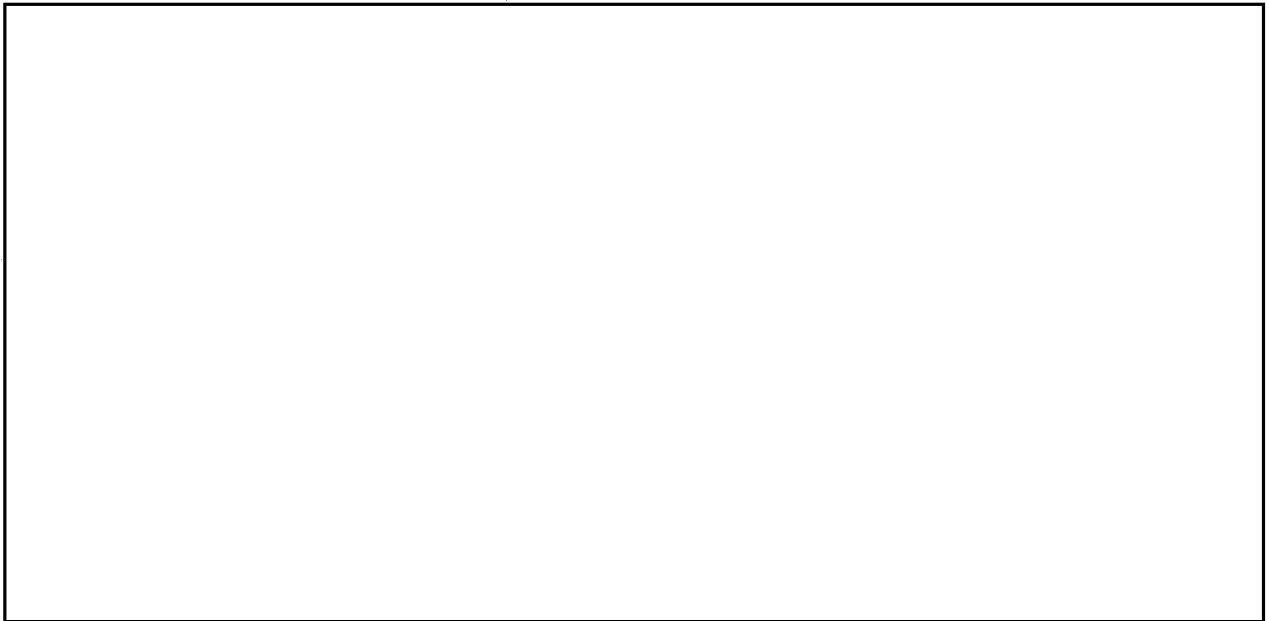

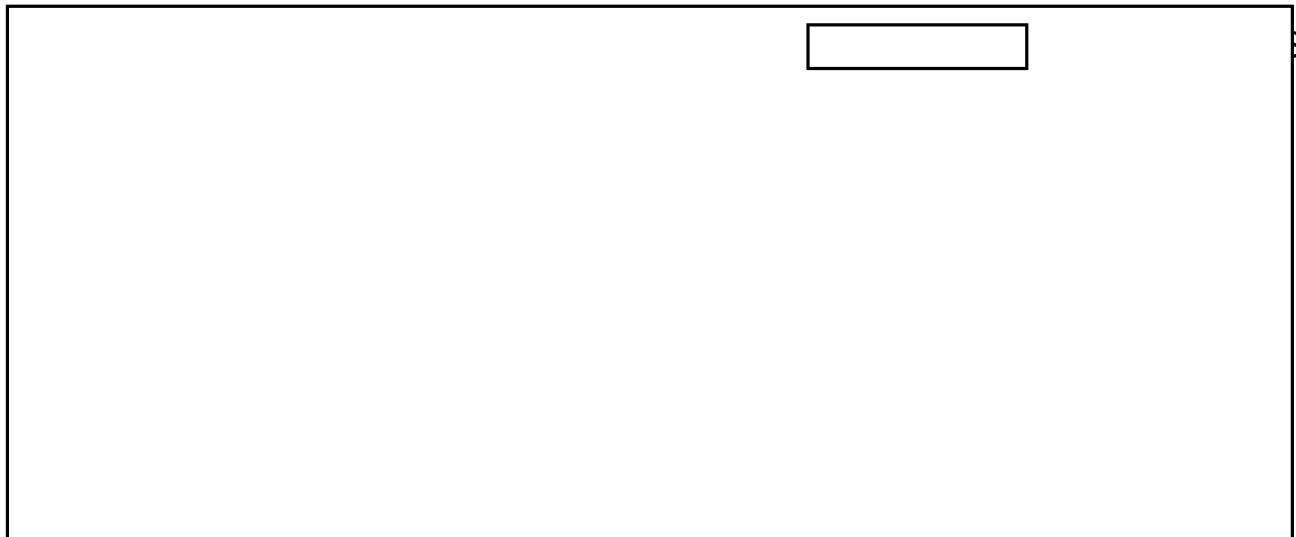

(Unclassified - FRO) LIAISON Called Bill Miller, Staff Director, Senate Select Committee on Intelligence, to alert him to the tour that had been set up for Elliot Maxwell and others on the Select Committee staff at NPIC on 25 August and added that I thought he would want to know since he may be operating on a compartmented system and wanted to be sure that the staffers taking the tour had a definite need to know. He assured me that those scheduled to take the tour were working on matters which gave them a need to know about NPIC.

Miller also mentioned that he understood he was to be briefed on the cuts in the DDO and asked what the status of that was. I told him that we were trying to set something up for next week. He said that he would be on leave next week and hoped we could do it this week. I told him I would get back to him.
