SUBJECT: Possible SNIE on the Kashmir Dispute

1. We have been informed that Mr. Cumming, at the request of Assistant Secretary of State Rountree, plans to propose at tomorrow's IAC meeting that a SNIE be undertaken on the Kashmir dispute. Although such an estimate would presumably provide some reassessment of the prospacts for a settlement, it would probably be directed primarily at estimating the likelihood of serious trouble in the probable event that Pakistan's projected re-raising of the issue at the UN Security Council this summer (and probably thereafter at the General Assembly) fails to produce any tangible results.

26 We believe that the situation remains generally as described in our existing estimate on India and Pakistan\* and that a new SNIE would merely reaffirm the long held conclusion that, despite the improbability of any mutually satisfactory solution, the chances of major hostilities between Pakistan and India remain small. However, a brief resurvey of the situation might be justified in the light of the developments of the last few months. Pakistan has scored a notable diplomatic victory over India in inducing the UN to reaffirm its support of a

plebiscite in Kashmir despite India's objections. There have been some signs of restiveness over the situation on the part of Azad Kashmir leaders, tribesmen, and members of the Pakistani military establishment. Since the Pakistan government's projected efforts to pursue its case at the UN will almost certainly fail to extract any real concessions from India, pressures for more direct action are likely to increase once the UN phase is over. Meanwhile, India, which is smarting and embarrassed over the diplomatic and prestige setbacks it has suffered at Pakistan's hands, may be in a more truculent mood, especially in view of its fear that continued US military aid for Pakistan will destroy India's military preponderance over Pakistan.

3. If a SNIE on Kashmir is authorized by the IAC, we recommend the following schedule:
