Notes.

Contracts shall be for a minimum period of one calendar month.

Payments shall be made monthly in advance on the basis of one-twelfth of the annual figure.

The minimum charge shall be for $\frac{1}{4}$ hour transmission for each customer for any daily transmission period up to and including 15 minutes.

For two or more daily periods the rate for each period shall be charged as a separate transmission and the total daily minutes shall not be cumulative.

Rental of lines from Client's offices to C. & W. C. T. O. shall be at Client's expense.
