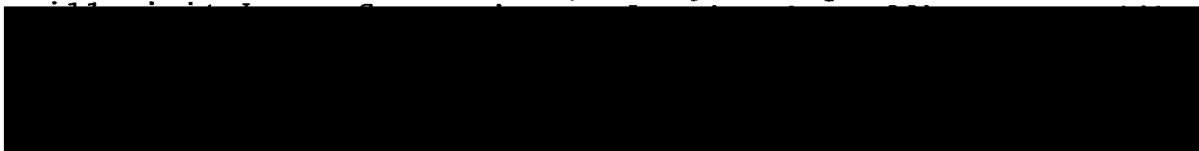

4. Co-op Program:

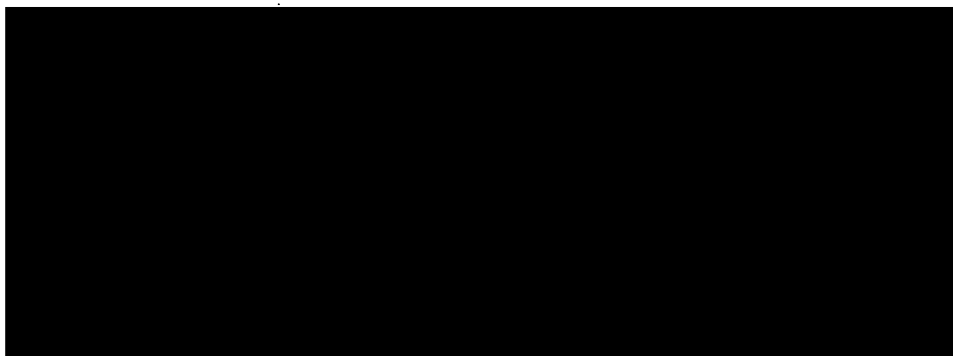

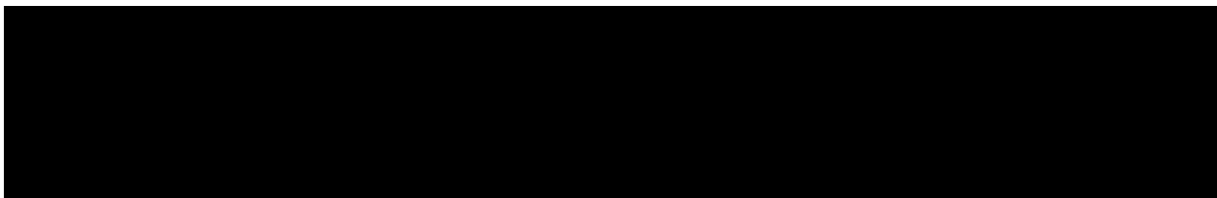
