The Office of Naval Intelligence furnished the following information to CIA for IAC dissemination in accordance with paragraph 3c of NSCID #7. This information was obtained by BIO-349 and was forwarded as ONI report 5-54.7

1. Merchant Vessels: During the period 25-30 December, 1953, source observed one Finnish, two Swedish, and three Polish flag ships in the harbor at Gdynia. Since these ships were seen underway, it was impossible to determine what cargoes they were loading and unloading.
2. Construction Activity: Source noted that several new commercial warehouses were in various stages of construction, and that others were being repaired. The breakwater at the entrance to Kanal Portowy appeared to be completed; at least no work was in progress during the above period.
3. Security Precautions: The search, which lasted three hours and was very thorough, was conducted by a party consisting of fifteen men and two officers. The usual security force was present at the pier.
4. Naval Vessels: No naval vessels of any kind were observed.
