Kalining	971 kc	Frequency being used by Rostov-on-Don.
Kaliningrad	1142 kc	Identity of station cannot be confirmed.

Kharkov	647 kc	Frequency being used by Russian station transmitting TASS material. Assignee has not made change from old channel of 385 kc.
Kiev I	209 kc	Assignee is using frequency.

Kishinev	998 kc	Assignee is splitting time between this frequency and that assigned Tiraspol.
