CZECHOSLOVAK GOVERNMENT DECREES, OCTOBER-DECEMBER 1953

[Comment: Following is a listing of Czechoslovak government decrees promulgated during the fourth quarter of 1953, arranged alphabetically according to ministry or agency concerned. The decrees are identified by month of promulgation, number, subject, and page, as published by the Czechoslovak Ministry of the Interior.

The sources of the list were the following three issues of Uredni List, a publication of the Ministry of the Interior: issue of 7 November, for decrees promulgated in October; issue of 5 December, for decrees promulgated in November; and issue of 21 January 1954, for decrees promulgated in December of 1953. The date of promulgation does not necessarily correspond to the effective date of the decrees.]

No 364. Deals with the transportation code for mass urban passenger transportation. Section 149, page 1415.

No 321. Establishes Technical State Standards for hydraulic brakes, open die steel forgings, porcelain insulators, and circular and shaped copper and copper alloy wire. Section 126, page 1321.

Standardization, Office for

By the following decrees, No 319 through No 380, the Czechoslovak Office for Standardization has established Technical State Standards for the commodities, services, and technical processes listed.

No 319. Mountments and suppositories [sic]; transport equipment; keys; pump fittings; clamping tools; aircraft ignition wire with rubber insulation; terminology for automatic regulation [sic]; flanged cast iron pipes. Section 125, page 1277.

No 322. Lumber. Section 127, page 1287.

No 326. Servicing a transformer; excavators; threaded flanges with neck; formed light metals; transportation equipment; distribution panels; parts required for public lighting systems. Section 129, page 1309.

No 329. Roller bearings; experimental [testing?] and operational pressures for diamond abrasive wheels; cast steel flange necks; unloading of mixed concrete; universal chucks; one-piece refrigerator doors; motor fuels; food products. Section 130, page 1311.

No 330. Porcelain insulators; drug bottles with special closures; forcing-off screws for slide rails [sic]; testing of electronic tubes; carboniferous substances; sulfuric acid; blotting paper; "Havana" paper, made from wood. Section 131, page 1315.

No 332. Selected types of food products. Section 131, page 1316.

No 334. Products of the general machine-building industry; products of the chemical industry, the light industry, and the food industry. Section 132, page 1319.

Wooden cable drums; conductors and wire cables; mobile [power?] supply systems for mines; gas, piped over long distances; heat-insulating materials; retractable foot pedal for use in starting a motorcycle engine; testing of solid fuels; tolerance deviations in pattern dimensions; electrotechnical directives; rotating electric machinery; office envelopes; penicillin powder. No 346. Products [unspecified] of the heavy machine-building industry and of the light industry. Section 139, page 1359.

No 349. Physical testing of rubber; three-stage, explosionproof induction motors; rails for crane tracks; coke for carbide production; mineral oils; penicillin ointments; pure chemicals and chemical agents; changing the electrical resistance of conductors. Section 141, page 1377.

No 350. Medicinal herbs; bottles for soup spices; raw materials for wrapping parchment; paper for copybook covers and inserts; paper for business envelopes; lighting equipment for motor vehicles; aluminum alloy castings. Section 141, page 1379.

No 352. Pure chemicals and chemical agents; mineral oils; technical and medicinal hydrogen peroxide; procaine penicillin G for aqueous solution; paper bags; wrapping parchment. Section 142, page 1382.

No 354. Technical potassium chlorate; technical sodium phosphate; paraffin and ceresin; "tritol" [trinitrotoluene?]; perora' penicillin tablets; dental penicillin pins [sic]; protective coatings; asphalts. Section 143, page 1389.

No 355. Pure chemicals and chemical agents; concrete mixers; automatic refrigeration plants; trailer couplings; hammers and mallets; straw-baling machines; single axle tractors [sic]; machining tolerances for steel castings; tolerances for steel and cast iron castings. Section 144, page 1393.

No 358. The production of periodicals; "sloupovina" [lumber for utility poles?]; hydraulic brakes; fire-fighting equipment; spreaders for artificial fertilizers; asphalts; testing of solid fuels; draining plugs with conical threading with or without magnets [sic]. Section 146; page 1405

No 360. Filtration fabrics; steel sheet distribution panels; flat welded flanges; welded flanges with neck; high carbon tool steel; alloy tool steels. Section 147, page 1407.

No 361. Square shovels; testing of paper; paper bags; building lumber; technical potassium chlorate; procilin [sic]; lacquer benzene [lacquer thinner?]; basic lead acetate; trehalose; mercuric iodide. Section 148, page 1411.

No 366. Bicycle inner tubes; bicycle tires; motorcycles; insulated aluminum strips; costume jewelry; leather drive belts; refined steel for domestic consumption; nutrient media for testing the sterility of biological preparations. Section 150, page 1424.
