1. Non-commissioned officers and men who finished their military service in armored units and are now in the reserve are directed to work in the State Agricultural Machinery Centers (POM-Panstwowe Osrodki Maszynowe).
2. Frequently, teams of the newly organized POM's consist entirely of former non-commissioned officers and men from the same military unit. For example, such was the case at the POM at Piastorzyn (Tuchola County, Bydgoszcz Voivodship) and at Bogolkowo (Zuin County, Bydgoszcz Voivodship).

Comment: [redacted] the majority of servicemen released from military service in the autumn of 1952 were compelled to work on state farms for one year.
