Agenda Item 1. The Board discussed certain proposals of the Rockefeller Committee and agreed that the Chairman would draft a letter conveying its views to Mr. Rockefeller.


Agenda Item 3. Matters related to Korean armistice prospects were discussed.

Agenda Item 6. Subject to later communication of the views of Messrs. Kyes and Stassen, the Board concurred in the recommendation of the CIA memorandum of March 30 about the External Research Program.

Agenda Item 7. Mr. Stassen called attention to important psychological aspects of the major policies being developed by the Administration.
