This will be accomplished as a purchase with current funds of SSU assets held by the Finance Division. Two DCI vouchers should be prepared by the Finance Division to cover this purchase in the normal manner.

2. The entries in the Fiscal Division accounts will be a debit to Account 136.7, Disbursements of Appropriated Funds Chargeable to Confidential Funds Allotments-DCI Certification-FY 1957, and a credit to Account 106.7, Disbursing Funds-FY 1957.

3. The Finance Division will debit Account 400.0, Accountability for Funds Acquired From SSU, with a credit to Account 136.7, Disbursements of Appropriated Funds Chargeable to Confidential Funds Allotments-DCI Certification-FY 1957.

4. The completion of the above deposits with the Treasury Department and the completion of the transactions shown will completely close out the SSU Reserve Account.
