1. Representative Otto E. Passman as Chairman of the Subcommittee on Foreign Operations of House Appropriations Committee with three other Subcommittee members is traveling on an extended tour of Europe and the Far East. Accompanying this group is Identity A. In his official capacity Identity A has received over the years detailed information concerning KUBARK budgetary matters and activities. [Redacted] (Identity B) invited Identity A to meet with the Chief of Station, [Redacted] to receive a thorough briefing on KUBARK activities in the area including such details on financial procedures and controls as he desires.

2. Identity A has been furnished the Chief of Station's name and has been requested to contact him [Redacted]. Identity A is most security conscious and recognizes he must split off from the Passman group for the purpose of this briefing. The group's scheduled time of arrival in [Redacted] is 1 October, and arrangements have been made for them to stay at the [Redacted]. Their time of departure from [Redacted] is 5 October. If no word is received within the first day of arrival, it is suggested that [Redacted] contact Identity A. [Redacted] has been briefed by [Redacted] and will be able to furnish additional information. For general guidance and background see Book Dispatch No. 993 and Supplement No. 1146. Headquarters desires that every effort be made to give Identity A as thorough, detailed and frank briefing as possible without divulging details of sensitive operations. Identity A is not authorized to receive information concerning COMINT and CHALICE.
