SUBJECT : Current Interest Items

1. Early Retirement

There is nothing new to report on our regulation. However, the Panel of Attorneys is scheduled to meet with us on 9 December and we are hopeful that they will soon clear the regulation so that we can proceed with BOB coordination.

2. Beni-Annual Review of Consultants

The Executive Director has requested that we submit a report in January on consultants. We are contacting each office involved to verify that the justifications submitted for the annual report are still valid. Our target for completing this report is 25 January 1965.

3. <u>Career Education Awards</u> The Director of Personnel of various departments and agencies were guests of the National Institute of Public Affairs at a luncheon meeting on 30 November. The Executive Director of MIFA gave a report on the Career Education Awards program and reviewed future plans. In brief, NIPA hopes to expand the program and over the next five years to phase out of it leaving the future conduct of this mid-career development program to the agencies concerned.
