Personnel should therefore submit their theses for clearance before they are turned in and should indeed inform the Agency of the subject matter in order to obtain approval in advance. knowledge of Agency employment automatically identifies the Agency with such projects and that the finished papers are often disseminated by service schools to the JCS and the military departments. He felt that Agency approval for specific projects would have to be decided on an ad hoc basis. Executive Director proposes to ask the Director of Training to include on his checklist for briefing Agency officers prior to outside training a notation to alert these officers to the need for Agency clearance of their individual projects.
