**MEMORANDUM FOR: Director of Central Intelligence**

**SUBJECT: The Association of General Counsel**

1. This memorandum contains recommendations for approval of the Director of Central Intelligence. Such recommendations are contained in paragraph 3.

2. Mr. Charles S. Maddock of the General Counsel Association has written that they are delighted we will participate in the meeting at Sea Island on May 15 and 16. We will be scheduled for Monday morning, May 15. We are invited to stay over until Tuesday but Tuesday's session will be for members of the Association only.

3. Mr. Maddock has asked if we can give him a title describing the nature of our presentation. He described the members of the Association as hard-bitten, skeptical lawyers and feels we should have something very concrete and definite to present them. He feels that Latin America is an area on which they definitely need some education. The theme, generally speaking, is better understanding between U. S. business and Government and better cooperation in their mutual problems. Some titles that have been suggested are:

- a. International Communism in Latin America
- b. Latin America - Dangers and Opportunities
- c. Latin America - Evolution or Revolution
- d. Latin America - Problems and Prospects

The Evolution or Revolution seems to me a good theme for a talk on the cooperation between business and Government. Would you approve my giving one of these or possibly some other title to Mr. Maddock and indicate whether you or Mr. Kirkpatrick will undertake this presentation. For your information they have offered to pay all travel and hotel expenses. Attorney General Kennedy will not be able to come and they are trying to get his Deputy, Byron White, as the principal speaker for Monday evening.
