SUBJECT: 12 July Meeting Between DDCI and Mr.  
Peter Bensinger, Administrator of the  
Drug Enforcement Administration (DEA)

1. Mr. Bensinger, who will meet with the DDCI on 12 July to discuss the briefing of the President of Colombia concerning corruption related to illicit narcotics traffic, has taken a personal interest in the preparation of a joint DEA-CIA statement of operating procedures regarding narcotics intelligence collection activities overseas. Mr. Bensinger may refer to the "DEA-CIA Guidelines" during the 12 July meeting.

2. A copy of the most recent draft of the "DEA-CIA Guidelines" is attached for your information. This version of the guidelines has been coordinated within DEA. The Narcotics Control Group, Policy and Coordination Staff, Directorate of Operations, will recommend certain language and substantive changes in the "Guidelines" before they are submitted for DDO review and approval.
