4. Progress Report

The Department of State has notified the US Embassy, Moscow, of the status of plans for the new Chancery. The preliminary design concept on massing of buildings on site within height limitations has been completed and approved. Informal discussions with the Soviets on this preliminary concept are planned about 18 March.

5. Reports by Members

a. The Acting Chairman introduced a draft DoD Directive which recommended that Department of the Army Technical Surveillance Countermeasures personnel be given their advanced training at the ITC. Since this would involve training an additional 20 to 40 persons annually, which translates to 2 to 5 courses covering a six-month period, the Chairman suggested that Mr. Fischer check with ______ of the ITC. Mr. Fischer said that the ITC would probably need additional instructors but would check with ______ to determine if this additional training could be given without restructuring the ITC or disrupting its present training program.
