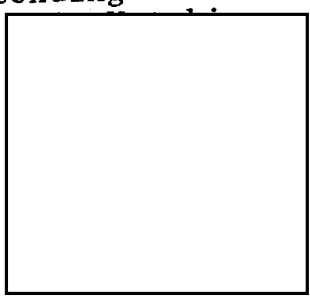

SUBJECT: Cross Program Resource Package Sub-Group Meeting

1. The Cross Program Resource Package Sub-group of the IRAC Working Group met at 1000 on 9 May at CIA Headquarters. Those attending were:

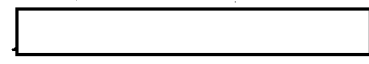

2. [Redacted] opened the meeting with a recap of the Sub-group's activities for benefit of those attending for the first time. [Redacted] then distributed copies of his draft outline for CPRP studies. He emphasized that the descriptive portion of the outline is needed and can be done now, but that the evaluation portion is more developmental.

3. A spirited discussion followed centered on how one could integrate requirements data into an MIS using CIRIS as a base, and also on the problem of identifying specific targets in the programming and budget phases of the DOD cycle.

4. The group then considered the proposed Report to the Working Group. After modifying the recommendations in line with [Redacted] suggestion to go forward on descriptive surveys and displays, the Sub-group agreed to the draft.
