DISSEMINATION PLAN: CHAIRMAN, RESEARCH AND DEVELOPMENT BOARD
NATIONAL MILITARY ESTABLISHMENT

SUBJECT: Foreign Intelligence Required by the Research
and Development Board

References: a) RDB 49/4.1 dated 13 June 1949
b) RDB 169/1 dated 23 December 1948

1. This will acknowledge receipt of reference memorandum requesting foreign intelligence in support of the Master Plan of the Research and Development Board.

2. The Central Intelligence Agency will endeavor to fulfill those portions of your request related to foreign research and development on weapons, weapons systems and techniques, exclusive of categories 10 and 13 of the Master Plan, and is developing its plans accordingly. Those plans, when completed, will be the subject of a future communication.

3. In the meantime, a series of discussions is being arranged between representatives of the Office of Scientific Intelligence of the Central Intelligence Agency and the Research and Development Board planning groups in order to arrive at those portions of the annual intelligence estimate to be given top priority for preparation by the 1 September 1949 deadline.

4. To supplement the annual estimates and to provide timely intelligence in the interim, plans have been made for the Central Intelligence Agency representatives on the Research and Development Board Committees and panels to present briefings at short intervals. By means of the annual estimate and the interim briefings, it is hoped to provide the Research and Development Board with the intelligence support which it requires in its operations.

5. With respect to categories 10 and 13 of the Master Plan, this Agency believes that discussions are necessary between representatives of CIA and RDB in order to clarify existing responsibilities for Intelligence Operations and Psychological Warfare and Cold War Operations. Accordingly, CIA can make no commitment with respect

to these two categories at this time. It is therefore requested that you designate representatives from RDB with whom representatives from CIA can enter into discussions on categories 10 and 11.
