Subject: National Intelligence Requirements - Middle East.

- 1. At their first meeting last year, the Deputies to the members of IAB decided that the Mational Intelligence Requirements for China should be prepared and published. Upon their publication, the Central Intelligence Group should undertake to coordinate and publish the MIR for USSR, Middle East and Rorea.
- 2. Much difficulty can be expected in defining the boundaries of the "Middle East" and in any such area, when defined, the intelligence problem will not be homogeneous throughout the whole area. It is, therefore, proposed that three sets of NIR be prepared for the general area known as the "Middle East".
- 3. It is requested that each agency propare its overall intelligence requirements in order of priority for each of the following areas:

In preparing these three sets of requirements,

- 4. In preparing these three sets of requirements, each agency should include only those requirements of very high priority. They should be stated, insofar as possible, in conformity with the principles and form of NIR - China (NIA Directive No. 8).
- 5. Upon their receipt, CIG will prepare the Current Essentials of National Intelligence and the National Intelligence Objectives, following the same procedure as employed in the development of NIR China.
