GENERAL POLICY OF THE UNITED STATES CONCERNING FORMOSA (NSC Action No. 325; Memo for NSC from Executive Secretary, same subject, dated July 28, 1950)

At its 62nd Meeting on July 27 the Council discussed the recommendations of the JCS contained in the reference memorandum, and noted the President's approval in principle of these recommendations subject to agreement by the Secretaries of State and Defense as to the specific content and wording thereof. The above decision subsequently transmitted to the Secretaries of State and Defense for appropriate action with the request that the final statement of policy as agreed upon by the Secretaries of State and Defense be furnished the Council for the information of all other Council members and the Secretary of the Treasury. Awaiting final policy statement by State and Defense. (See also related items in Sections 1, 2, 3 and 4.)

A letter from the President and the report by the Secretaries of State and Defense referred to therein, were circulated as NSC 68 and discussed at the 55th NSC Meeting. The Secretary of the Treasury, the Economic Cooperation Administrator, the Director, Bureau of the Budget, and the Chairman, Council of Economic Advisers, participated in this Council action. Pursuant to NSC Action No. 289-b, an ad hoc committee was established to prepare a response to the President's directive in NSC 68 as a matter of urgency. Fursuant to NSC Action No. 302-b, this ad hoc committee was further authorized to study and make recommendations with respect to the organization of the government to implement the Conclusions of NSC 68 in the event those Conclusions are approved. At its 62nd Meeting the Council noted a statement by the President on the sub-ject, establishing the deadline date of September 1, 1950 for sub-mission of the Council's response to his directive in NSC 68 (NSC Action No. 321.) The President's statement was accordingly referred to the ad hoc committee for appropriate action, and the committee met again on Monday, July 31 to determine the most ex-peditious means of completing a draft response to the President's directive for Council consideration prior to September 1. Pursuant to par. 28 of NSC 18/4, approved by the President on November 18, 1949, the Secretaries of State and Defense, the Acting Chairman, NSRB, the Attorney General, and the Director, Bureau of the Budget, designated representatives to assist in the preparation of a study on the methods by which the United States can make available military assistance to meet emergency needs not provided for in existing legislation. At a meeting of these representatives on December 12, 1949, an outline for the study was agreed upon and drafts of certain sections undertaken by State, Defense, and Justice. The Director of Central Intelligence has prepared an estimate of likely contingencies where military assistance may be requested which is not provided for in existing legislation, together with an analysis of problems in connection therewith peculiar to particular foreign countries or areas. Over-all draft report prepared by Defense on the basis of the 3 section drafts by State, Defense, and Justice, circulated February 14, 1950, and considered, together with a memo by Budget, at a meeting on March 9. Revised draft report by State circulated for Committee study and discussion July 17, 1950. Awaiting consideration at a Committee meeting to be scheduled at an early date.

JAPANESE PEACE TREATY

PROGRESS REPORT ON NSC 26/2

Pursuant to NSC Action No. 303-b, the Secretary of Defense has been requested to obtain the views of the JCS as to what military steps they contemplate in support of the plans developed pursuant to NSC 26/2, in view of their decision with respect to the battalion of Marines referred to in the reference memorandum dated May 9, 1950. APPRAISAL OF FOREIGN ECONOMIC INTELLIGENCE REQUIREMENTS, FACILITIES AND ARRANGEMENTS RELATED TO THE NATIONAL SECURITY (Memo for NSC from Executive Secretary, same subject, dated February 7, 1950; NSC Action No. 282)

In approving the proposal by the Acting Chairman, NSRB, in the reference memo, the NSC directed (NSC Action No. 282) the Central Intelligence Agency, in collaboration with the government agencies concerned, to organize and conduct a study of foreign economic intelligence requirements, facilities and arrangements related to the national security and, based on the findings of this study, to prepare for Council consideration and action a comprehensive plan for satisfying the foreign economic intelligence requirements of the national security and for a coordinated interagency effort to this end based on a definite allocation of responsibilities among the agencies concerned. Awaiting report by the Central Intelligence Agency.
