Origin: The Council on July 30 directed the Economic Defense Advisory Committee to review NSC 122/1 on the subject in the light of NSC 152/2, and to submit recommendations for any revision in NSC 122/1 required to make it conform to NSC 152/2 (NSC Action No. 864-b).

Current Status: Recommendations prepared by the Planning Board after a review of NSC 122/1 pursuant to the above Council action have been transmitted by the reference memorandum of October 19 are scheduled for consideration on November 5.

Current Status: A summary of courses of action prepared by State and Defense with the assistance of CIA pursuant to NSC Action No. 949-c is to be circulated for consideration by the Council at its meeting on November 5. (See also related project in Section IV below.)

Current Status: The draft statement of policy contained in the reference report by the NSC Planning Board on the subject (NSC 166) which was prepared in response to paragraph 19 of NSC 154/1 and NSC Action No. 777-d (2), is scheduled for consideration on November 5, 1953.

4. UNITED STATES OBJECTIVES AND COURSES OF ACTION WITH RESPECT TO FORMOSA AND THE CHINESE NATIONAL GOVERNMENT

S. policy toward Formosa, the Chinese Nationalist Government, and other anti-Communist Chinese forces and in the light of views of the JCS, contained in NSC 128 (NSC Action No. 624-b).

Current Status: The draft statement of policy contained in the reference report on the subject (NSC 146/1), prepared by the Planning Board on the basis of a review of NSC 146 in relation to NSC 166 (see project just above), is scheduled for consideration November 5, 1953.

Origin: The NSC, on February 25, 1953, after discussing recommendations of the Department of State Panel of Consultants on Disarmament contained in their report on the subject (reference memo of February 4), referred the report to the Senior NSC Staff, directing it, with the assistance of Dr. Vannevar Bush, to report back to the Council on possible means of carrying out the recommendations (NSC Action No. 725).

Current Status: Awaiting: (a) further report by OCB pursuant to NSC Action No. 869-b on progress made in the development and implementation of the program for informing the American people, and (b) consideration by the Planning Board at its meeting on November 4 of the memorandum by the Chairman of the Ad Hoc Committee and its attached report (relating to Recommendation 2 of the report transmitted by the reference memo of February 4) which have been circulated by the reference memo of October 27.

Origin: The Council on June 25 in connection with its action on "The Japanese Treaty Islands" (see NSC Action No. 824, para. 4 of NSC 125/6 and reference memo of August 7) agreed that the Secretary of Defense, in collaboration with the Department of State, the Bureau of the Budget, and other interested agencies, should recommend for Council consideration a policy on the civil administration of those Ryukyu Islands remaining under U. S. jurisdiction, which would reduce U. S. responsibility for such civil administration as rapidly as compatible with U. S. military requirements.

Current Status: Awaiting a report by the Defense member based upon study of detailed comments by Planning Board members on the proposed directive prepared by Defense and transmitted by the reference memo of October 26. Tentatively scheduled for November 4.

S. policy toward Finland, as contained in NSC 121, designed to lessen Finland's economic dependence on the Soviet bloc (NSC Action No. 905).

Current Status: Awaiting proposed changes by FOA in U. S. policy toward Finland. Tentatively scheduled for Planning Board consideration November 9.

Origin: NSC 159/4, approved by the President on September 25, provides: (a) (para. 20-b (3)), that action on Recommendation 8 of NSC 159/1, should be deferred pending report to the Council on the results of a 30-day check of actual entry of unaccompanied Soviet bloc diplomatic baggage and shipments; (b) (para. 20-b(4)), that pending the results of this check, Recommendation 9 of 159/1 should be confined to accompanied baggage and effects; (c) (para. 20-e)), that the elements in the program of countermeasures relating to more effective prevention of illegal arrivals of persons and more effective control of smuggling require further consideration by the Planning Board before action is recommended to the Council.

Current Status: Awaiting: (a) report from Treasury and Justice on the results of the 30-day check referred to above, (b) further consideration by the Planning Board of the recommendations referred to in (c) above. Tentatively scheduled for November 12. (See also related projects in Section IV below.)

10. UNITED STATES POLICY AND COURSES OF ACTION TO COUNTER POSSIBLE SOVIET OR SATELLITE ACTION AGAINST BERLIN

Current Status: Awaiting preparation by the Board Assistants of draft amendments to NSC 132/1. Tentatively scheduled for Planning Board consideration November 16.

Origin: Draft statement of policy and staff study prepared by State were transmitted by reference memo of March 4 for consideration by the Senior Staff.

Current Status: Awaiting consideration by the Planning Board on the draft statement of policy of August 18.

16. THE POSITION OF THE UNITED STATES WITH RESPECT TO IRAN

Ref: Council - NSC 136/1; NSC Action No. 891
Plan. Bd. - Memo, August 3, 1953; Record of Meetings, July 30, August 6 and August 24, 1953

Origin: The Planning Board on July 30 discussed U. S. policy toward Iran in the light of recent developments and estimates of the situation and agreed to consider at an early meeting the desirability of a basic review and revision of U. S. policy toward Iran.

Current Status: Awaiting further consideration by the Planning Board.

17. UNITED STATES OBJECTIVES AND COURSES OF ACTION WITH RESPECT TO LATIN AMERICA

Ref: Council - NSC 144/1; Annex to NSC 144

Origin: NSC 144/1, approved by the President on March 18, stated (para. 3) that its limited purpose was to define our objectives and courses of action concerning important problems common to the area; policies toward specific country situations, such as those in Argentina and Guatemala, were left for subsequent papers.

Current Status: Awaiting a draft report from State based upon its review of United States policy toward Latin America, including United States policy toward specific countries in Latin America. (See also related project just below.)

18. U. S. OBJECTIVES AND COURSES OF ACTION WITH RESPECT TO VENEZUELA

Ref: Council - NSC 144/1 and Annex to NSC 144; NIE-67 and NIE-70; Memo, subject, "The National Security Interest in Successful Trade Agreement Negotiations with Venezuela", February 29, 1952
Plan. Bd. - Memo, October 22, 1953

Origin: A draft statement of policy and staff study on the subject, prepared by State were transmitted for the consideration of the Planning Board by the reference memo of October 22.

Current Status: Awaiting consideration by the Planning Board. (See also related project just above).

19. DEVELOPMENT OF NUCLEAR POWER

Ref: Council - Memo, October 20, 1953; NSC 162/1, paragraph 40-f; NSC 149/2, Paragraph 7
Plan. Bd. - Memo, October 20, 1953; Record of Meeting, October 28, 1953

Origin: A letter from the Secretary of Commerce on the subject was circulated to the Council for information by the reference memo of October 20 and referred to the Planning Board for study and for the preparation of recommendations for Council consideration.

Current Status: Awaiting a report on the subject by the special committee constituted at the Planning Board meeting on October 28, and consisting of officials designated by Defense, Commerce and AEC, assisted by Dr. Beckler as scientific adviser and Mr. Farley as executive secretary.

20. THE POSITION OF THE UNITED STATES WITH RESPECT TO THE COMMUNIST THREAT TO ITALY

Ref: Council - Progress Report dated May 20, 1953 by the Acting Secretary of State on NSC 67/3
Plan. Bd. - Record of Meeting, October 29, 1953

Origin: The reference Progress Report on the subject advised that the Department of State considers that NSC 67/3 has, in some respects, been overtaken by events, and that a new draft is under preparation for submission for the consideration of the Council, which will reflect conclusions drawn from the outcome of the Italian national elections held on June 7, 1953.

Current Status: Awaiting preparation of a draft report by State.

21. THE POSITION OF THE UNITED STATES WITH RESPECT TO YUGOSLAVIA

Ref: Council - NSC 18/2 and 18/6
Plan. Bd. - Record of Meeting of Senior Staff, January 29, 1953; Record of Meeting of Planning Board, October 29, 1953

Origin: The Senior Staff on January 29 agreed to prepare recommendations for Council consideration on several urgent and immediate policy questions, including this policy question.

Current Status: Awaiting preparation of a draft report by State.

22. U. S. POLICY TOWARD TRIESTE

Ref: Plan. Bd. - Record of Meeting, October 29, 1953

Origin: Mr. Cutler on September 14 called the Planning Board's attention to the new project being initiated on this subject.

Current Status: Awaiting a report from State. (See also related projects just above.)

IV. PROJECTS ASSIGNED TO OTHER DEPARTMENTS AND AGENCIES

1. U. S. POSITION WITH RESPECT TO THE REGULATION, LIMITATION AND BALANCED REDUCTION OF ARMED FORCES AND ARMAMENTS

Ref: Council - NSC 112 and 112/1; Progress Report dated January 19, 1953 by the Under Secretary of State on NSC 112; Memos, "Formulation of a United States Position with Respect to Regulation, Limitation and Balanced Reduction of Armed Forces and Armaments", February 17 and June 3, 1953; NSC Action Nos. 717-b, 899 and 909

Origin: At its meeting on September 9, 1953, the Council adopted the recommendations contained in paragraphs 7-b and 8 of NSC 112/1 and agreed to recommend to the President that the Secretaries of State and Defense and the Chairman of the Atomic Energy Commission be appointed a special committee to review, as a matter of urgency, the current policy contained in NSC 112, with particular reference to the international control of atomic energy, and to report back to the Council their findings and recommendations. (NSC Action No. 899)

Current Status: Awaiting report by the special committee. Tentatively scheduled for Council consideration on November 12.

2. ANALYSIS OF POSSIBLE COURSES OF ACTION IN KOREA

Ref: Council - NSC 147; NSC Action Nos. 759, 777-e, 782, 787 and 794; Memo, "Future Courses of Action in Connection with the Situation in Korea", March 30, 1953; NIE-80; SE-41

Origin: A report on the subject prepared by the NSC Planning Board in the light of the estimate of the JCS transmitted by the reference memo of March 30, was submitted as NSC 147 for the consideration of the Council.

Current Status: Awaiting a report based upon review pursuant to NSC Action No. 949-d by State and JCS, with the assistance of CIA as appropriate, of the military and diplomatic measures provided in NSC Action No. 974. Scheduled for Council consideration on November 19.

3. REVIEW OF EXISTING INTERNAL SECURITY LAWS

Ref: Council - NSC Action No. 910-b

Origin: The Council on September 17 agreed that the Department of Justice, with the assistance of the IIC and the ICIS, should review existing internal security laws in their entirety with a view to submitting for Council consideration constructive proposals regarding possible legislation which might be introduced at the next session of Congress (NSC Action No. 910-b).

Current Status: Awaiting report by Justice. Tentatively scheduled for November 23.

4. CONTINENTAL DEFENSE

Ref: Council - NSC 159/3; 159/4; NSC Action Nos. 915 and 946

Origin: The President on September 25, 1953 approved NSC 159/4 as a guide to the respective departments and agencies in implementing their programs during FY 1954 and in developing their programs for future years, subject to (1) Before November 22, a more precise definition by the Department of Defense of certain programs and their phasing, and the identification of the portion of Defense Department effort and costs related to such defined programs; and (2) Before December 15, determination by the Council of the manner of financing the recommended integrated programs for continental defense in FY 1954 and future years, in proper relation to the over-all budget and taking into account FY 1955 budget submission by the departments and agencies; and noted that the Director of Central Intelligence will submit recommendations to the Council regarding the implementation of paragraph 11 of NSC 159/3 on "Improved Intelligence" at the time that the Council considers the report by the Department of Defense submitted to (1) above. (Note: The dates in (1) and (2) above were changed from November 15 and December 1 respectively by NSC Action No. 946).

Current Status: Awaiting: (a) Report before November 22 from the Department of Defense pursuant to (1) above (tentatively scheduled for Council consideration November 23), (b) recommendations from the Director of Central Intelligence regarding the implementation of paragraph 11 of NSC 159/3 and (c) a determination by the Council before December 15 pursuant to (2) above. (See also related projects above in Section III).

5. FY 1955 BUDGET CONSIDERATIONS

Ref: Council - NSC 161, No. 11; NSC Action Nos. 930 and 945

Origin: The Council at its meeting on October 13: (a) discussed the subject on the basis of oral presentations by the Director, Bureau of the Budget, the Chairman, AEC, the Director, FOA, the Secretary of Defense and Assistant Secretary of Defense McNeil; and (b) requested the Secretary of Defense, the Director, FOA, and the Chairman, AEC, to submit to the Council at its meeting on October 29, interim reports of estimated FY 1955 expenditures for their respective programs, to the extent that they had then been reviewed and coordinated within each agency in the light of the Council's discussion (NSC Action No. 930).

Current Status: Awaiting final consideration of the subject at the Council meeting on December 15 based upon a report by the Secretary of Defense pursuant to NSC Action No. 945-a and further reports by the Director, FOA, and the Chairman, AEC.

6. ORGANIZATION OF THE GOVERNMENT WITH RESPECT TO INTERNAL SECURITY AND CONTINENTAL DEFENSE FUNCTIONS

Ref: Council - NSC 159 and 159/4, para. 14; NSC Action No. 873-d

Origin: The Council on August 6, 1953 (NSC Action No. 873-d) noted that the President requested Mr. Flemming to establish a special task force to study and make recommendations on improving the organization of government with respect to internal security functions and with respect to the continental defense functions covered in Part VI of NSC 159.

Current Status: Awaiting recommendations from Mr. Flemming. (See also related projects above and in Section III).

7. ELECTRO-MAGNETIC COMMUNICATIONS

Ref: Council - NSC 169; NSC Action Nos. 812, 840 and 934; Memo, July 14

Origin: By the Council action of July 11 on the subject transmitted by the reference memo of July 14 the Director of ODM was designated as coordinating authority to prepare a progress report, in consultation with State, Defense, CIA and other interested agencies by January 1 as to the recommendation contained in paragraph 3 of the action (subsequently incorporated in NSC 169 as paragraph 3). By NSC Action No. 934-d of October 22 the Director

of ODM was directed to report to the Council, in connection with his January report such information as may then be available as a basis for decision on the subject of expanding or discontinuing U. S. high-frequency psychological broadcasting.

Current Status: Awaiting report by the Director of ODM pursuant to the above Council actions. Tentatively scheduled for January 1.

8. EFFECT ON NATIONAL SECURITY INTERESTS IN LATIN AMERICA OF POSSIBLE ANTI-TRUST PROCEEDINGS

Ref: Council - Memo, June 1, 1953; NSC Action No. 805

Origin: A report by the NSC Planning Board on the subject (reference memo for June 1) was considered by the Council on June 1, 1953 and it was agreed that in view of the adverse effects and national security interests in Latin America of the proposed anti-trust proceedings: (a) The proposed anti-trust proceedings should be postponed, without prejudice to the Government for one year, and (b) The Attorney General should be directed to negotiate with the company, as a matter of urgency, for the elimination of practices deemed to be inconsistent with U. S. anti-trust laws, reporting back to the NSC on the results of the negotiations (NSC Action No. 805).

Current Status: Awaiting report by the Attorney General. Tentatively scheduled for June 1954.
