1. SALT RES (REFTEL) WAS APPROVED BY FIRST COMMITTEE
82-0-30. ABSTENTIONS INCLUDED US, USSR, UK, FRANCE, ITALY,
NETHERLANDS, BELGIUM, GREECE, PORTUGAL, TURKEY, CANADA,
AUSTRALIA, JAPAN, ISRAEL, CHILE, IRAQ, SENEGAL, DAHOMEY,
HONDURAS, CUBA, BULGARIA, BYELORUSSIA, CZECHOSLOVAKIA,
HUNGARY, MONGOLIA, POLAND, UKRAINE. CHINE DID NOT PARTI-
CIPATE IN VOTE.

2. IN EXPLANATION OF VOTE NOV 15, ROSHCHIN (USSR) SAID
SOVS COULD NOT SUPPORT OPERATIVE PARA 1 BECAUSE IT ATTEMPTS
TO PREJUDGE SCOPE OF FUTURE LIMITATIONS AND PUTS FORWARD
CONDITIONS FOR FUTURE AGREEMENTS. USSR ALSO COULD NOT AGREE
TO OPERATIVE PARA 2. OTHERS CANNOT CONSTANTLY BE INFORMED
IN ADVANCE OF RESULTS OF EXTREMELY COMPLEX BILATERAL
TALKS. MARTIN (US) EXPLAINED US ABSTENTION IN ACCORDANCE
WITH INSTRUCTIONS. BUSH
