
Although it is clear that the Agency has the requisite legal authority to make such expenditures for operational purposes, it has also become apparent to us that the whole issue of the Agency's existing policies and practices in the area of representation allowances raises significant and potentially troubling political and legal questions. Accordingly, this Office believes that it would be useful in the near future for representatives of DDCI, OGC, DDO, IG, OLC and the Office of Comptroller to conduct a coordinated review and analysis of the manner and scope of the representation allowance expenditures presently being made by the Agency and the possible political operational and legal ramifications presented by this ongoing pattern of expenditures.

1. Deputy Directors shall submit to the Director, prior to the beginning of each fiscal year, their proposed schedule of maximum allowances for senior officials under their jurisdiction assigned to permanent posts of duty outside the continental limits of the United States. After approval by the Director, Deputy Directors are authorized to grant representation allowances, and to make adjustments therein, within the total amount approved by the Director provided, however, that any adjustment resulting in an allowance exceeding \$3,600 per annum must receive prior approval by the Director.

2. Deputy Directors are also authorized to grant representation allowances to senior officials for expenses to be incurred while they are in a travel status in an area outside the continental limits of the United States, including supplemental per diem not to exceed \$10 per day, provided that such expenditures in excess of \$1,000 for any single trip must receive prior approval by the Director.


