

1. In talking with Rick Inderfurth, of the Senate Select Committee on Intelligence staff, he raised a matter which he had touched on before which was the possibility of a visit by Senator Gary Hart (D., Colo.) and himself to the . He said he and the Senator had discussed this and the Senate felt that other members of the Select Committee might wish to go down also.

2. Inderfurth has asked for suggestions from us about such a visit, that is, how long it would take to have a meaningful visit, who they would meet and what kind of training courses it might be appropriate for them to observe. I told Inderfurth I thought there would be no problem in arranging for this and asked him about timing. He said they were thinking about sometime in middle or late September, depending on the Senate schedule. If they are unable to go then, they will probably have to put it over until after Congress adjourns on 2 October.

3. Per our conversation on this subject, I will raise the matter with the Director and if he agrees to such a visit, I would appreciate your recommendations.
