Attachment (b) recommends that there be added to paragraph 2d of Attachment E of reference (a) the following: "that reimbursement be effected in the currency in which the expense was initially incurred", or "that reimbursement will be made in a currency mutually agreed upon by both parties at an equitable rate of exchange based upon the prevailing 'free' rate at the time of settlement".
