## FOREIGN PHONE FIRMS' NATIONALIZATION SOUGHT

Lima Diplomatic Information Service in Spanish 1934 GMT 23 May 69 p

[Text] Lima, 23 May-In his most recent meeting with the productive sectors, Transport and Communications Minister Gen Anibal Meza Cuadra stated that the progressive nationalization of foreign companies exploiting the telephone services in the country must be done, according to our legal means and economic possibilities. Peru is one of the few countries in the world where total exploitation of telecommunications is not in the hands of national enterprises, he added.

MISSING OFFICIAL--Santiago, 3 June--The deadline ending the official search for a missing Piper Cub and its occupants, Emilio Oelckers, director of the Investigation Department, and four other persons concluded today. Nevertheless, search operations will continue indefinitely. It is believed that the aircraft will not be found until spring comes, when the snow which has fallen in the past 8 days begins to melt. Meanwhile, Tarapacas Police Chief Luis Jaspard da Fonseca has been named as investigations director. It has been confirmed that the Investigations Department deputy director, Eduardo Zuniga, will be transferred to an important job with the Production Development Corporation (CORFO).
