Access to Henry Kissinger's SALT Files

- 1. Action Required: See recommendation, paragraph 4, below.
- Background: Your memo of 28 August 1978 (opposite) asks whether Kissinger's SALT files would be valuable to our analysts. The answer is definitely affirmative. Access to these files would:
- -- allow us to place in perspective Soviet negotiating tactics and programmatic decisions made during the SALT ONE process;
- -- provide a more authoritative background in assessing current Soviet programmatic changes as they relate to or are influenced by the SALT TWO negotiations (e.g., changes in MIRV deployment programs);
- -- provide insights of significant value in understanding Soviet behavior in strategic matters beyond the more narrow SALT context.
- 3. Possession of a copy of these files would be highly desirable to facilitate long term analysis. If necessary we would certainly settle for access to the originals if that were the ground rules.
- 4. Recommendation: That you seek to obtain possession of or access to Kissinger's SALT files.
