MEMORANDUM FOR THE RECORD

SUBJECT: Concurrence in Amendment No. 3 to Contract No. HF-AP-1940 with The Firewel Company, Inc., Project Air Force

This memorandum contains a recommendation submitted for 1. concurrence of the undersigned. Such recommendation is contained in Paragraph 5.

2. Contract No. HF-AP-1940 provides for the services of a Senior Field Representative at Laughlin AFB for the Air Force. Amendment No. 3 to the contract incorporates revised man-day rates into the contract effective 1 December 1960, adjusts the amount of funds allotted to the contract and extends the period of performance to no later than 31 July 1961.

3. This Amendment No. 3 provides for the following adjustments in the amounts obligated to Contract No. HF-AP-1940:
