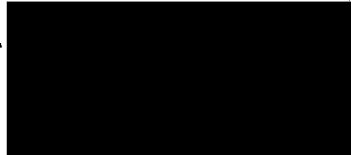

AMENDED PAYMENT PLAN FOR HYCON MFG. COMPANY

Company and mailed with a sterile form showing the appropriate contract number and invoice (voucher) number(s) for which the check is in payment.
4. Checks will be transmitted to the Hycon Mfg. Company in double envelopes. The outer envelope will be addressed to:



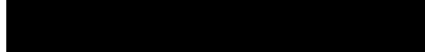

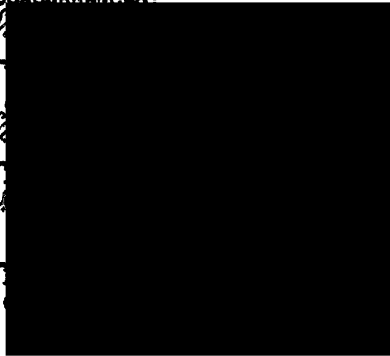
