Dear Dick:

Once again we are in the process of preparing the Project and FOG Budget for the forthcoming Fiscal Year, 1963 (1 July 1962 - 30 June 1963). It is requested that budgetary estimates be submitted to cover the following anticipated procurements with your Company:

a. Contractor Technical Representatives.

1. Project. Furnish personnel to support operations as follows:

(a) At two (2) overseas sites for a period of one (1) year.

(b) At one (1) domestic site for a period of one (1) year with the assumption that stagings will require the services at overseas locations approximately 1/3rd of the time.

The estimate should be in sufficient detail to reflect the quantity of personnel, the cost involved by a man-month rate and travel and per diem costs. Contract arrangements to be as they presently exist under Contracts Nos. SC-59 and SC-61.

2. FOG. Estimate should be prepared assuming the same level and scope of operations as was experienced during FY-1962, and should include man-month rates for domestic and overseas service. Contract arrangements to be as they presently exist under Contract No. SC-58.

b. Repair, Overhaul and Flight Testing of Equipment, "Common" Customer (Project and FOG). Furnish necessary facilities, materials and services to repair, overhaul, modify and test Project and FOG equipment as it may be returned to the factory from time to time. Estimate should assume the same level and scope of operations as experienced during FY-1962. Funding ratio for the "Common" Customer will be 20% Project/80% FOG. Again, as during FY-1962, funding for IRAN, TWX, BCP's, etc., will be furnished separately by each Customer. Contract arrangements will be as they presently exist under Contract No. SP-1923.

c. Spare Parts, Test Equipment, Modification Kits., Etc., "Common" Customer (Project and FOG). Estimate should be prepared on the same basis as paragraph b., above. Contract arrangements to be as they presently exist under Contract No. SP-1922.

d. Operations of "Connie". Estimate should be prepared assuming the same level and scope of operations as experienced during FY-1962.* Contract arrangements to be as they presently exist under Contract No. COM-200.
