[Redacted] LIAISON Received a call from Bill Miller, Staff Director, Senate Select Committee on Intelligence, who informed me the Committee had no objection to our releasing the section of the Director's 6 December 1977 testimony before the Committee on the Frank Snepp case to the court under terms of a subpoena. Miller did propose a formal exchange of correspondence on this request, however, and I agreed. I also talked about this request with Keith Raffel, of the Committee staff, several times during the day. I also discussed with Miller the request of Senate Budget Committee staff member Mike Pillsbury for compartmented clearances. Miller informed me the Committee had decided not to approach Senator Henry Bellmon (R., Okla.), Ranking Minority Member of the Budget Committee, but instead would await a formal request from the Budget Committee that Pillsbury have access to the Committee's FY-1979 authorization report.

Dear Mr. Wilson:

At the request of the officers of TIME Inc. in New York, I have been trying to identify and evaluate the source of a statement which appears in a 1975 report of the Senate Select Committee on Intelligence entitled, "Covert Action in Chile, 1963-1973." On page 25, the report says: "According to CIA documents, the TIME correspondent in Chile apparently had accepted Allende's protestations of moderation and constitutionality at face value. Briefings requested by TIME and provided by the CIA in Washington resulted in a change in the basic thrust of the TIME story on Allende's September 4 victory and in the timing of that story."

Since this statement in the report was based on "CIA documents," we would like to obtain copies of those documents. I discussed this with Dale Peterson in your Public Affairs office and he provided a copy of the point paper dated September 18, 1970 on which the briefings were based and which had previously been released. He suggested that I write to you for copies of the other relevant documents.

I am, therefore, requesting copies of the documents sent to the Senate Select Committee which report on briefings given to TIME correspondent Jerry Hannifin in September 1970 and which state that these briefings had influenced or altered the content of TIME's story.

OC should be able to recover the documents. (OC would have to do the review, probably.)

Please let me know if you need further details to identify the material we are asking for. Thank you for your help.
